Scott Weygand, Chris Grace, Tony Picklesimer and Tiffany Bittner were "Ayes" and Cody Sumners and Casey Morris voted "Nay".

Approval of City of Chelsea Bills to be paid was next on the agenda. A motion to approve the city's bill was made by Chris Grace and seconded by Casey Morris. A voice vote was taken and it was a unanimous, "Yes".

Emily Sims, Chelsea Public Library, reminded the council of programs coming up at the Library.

Joe Lee, Fire Chief, announced the City of Chelsea would be under a burn ban from May 1<sup>st</sup> – October 31<sup>st</sup>. The Fire Department no longer issues burn permits. They are issued by ADEM.
